RE: Training Requirements

Dear Journeyperson Tile Layer or Finisher,

March 31, 2017 a short two months from today will end the first contract year for the new Tile Agreement, this date also marks the due date for completion of the first years Journeyperson Training requirements set forth for all Journeyperson Tile Layers and Tile Finishers. The immediate requirement that needs to be satisfied by March 31, 2017 is \*OSHA 10, which may be set up in English or Spanish by contacting the Tile Coordinator Lupe Ortiz at 510-409-8450, [lortiz@bac3tilejtc.com](mailto:lortiz@bac3tilejtc.com). The Tile Coordinator will need the following information:

- Full name, and membership number as printed on your IUBAC membership card
- Current mailing address
- Phone number
- Email address for contact information

There is no cost to the member for the OSHA course. The member will have only one chance to pass the OSHA course, which has a pass-fail grade system. A \$199.00 stipend will be paid to the member upon completion of OSHA 10 by the LMCC, \$597.00 for OSHA 30.

\*Note: Below is a list of J/P upgrade classes which will also satisfy your first-year requirement: OSHA 10, OSHA 30, CPR and First Aid, Forklift, JLG, Scissor lift training, Foreman Training, Gauged Porcelain Tile Panels "TPT", Grouts, Field Installation Substrate Requirements, Membranes and Mud Beds, ACT Orientation, Understanding TCNA *handbook* & ANSI Workshop, any ACT Certification including: Thin Porcelain Tile, Grouts, Membranes, Large Format Tile, Showers, Mud Floors, Mud Walls. (All ACT certifications require a manipulative and online test be completed to satisfy the requirement.)

If you have already taken one of the above J/P upgrade courses as a journey person; contact Lupe Ortiz the JATC Coordinator 510-409-8450 to be sure your attendance has been documented and your first-year requirement has been satisfied.

The training requirements do not apply to apprentices, but any apprentice who wishes to take OSHA 10 training is encouraged to do so, and is eligible to receive a stipend from the LMCC.

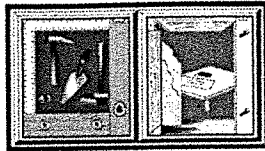
